



- The Admission process for the session 2023-2024 is ONLINE only vide our website <u>www.davdegreelu.in</u>
- There will be no OFFLINE mode of ADMISSION.
- Students are required to fill their REGISTRATION Form ONLINE only.
- REGISTRATION FEE is rupees 1000.00 only for this course. Students should submit the Registration Fee in HDFC BANK vide College website www.davdegreelu.inanddownload the hard copy.
- Immediately after filling the REGISTRATION form, students are required to fill the APPLICATION Form ONLINE only. They are required to fill all the requisite information and finally SUBMIT it ONLINE only.
- Students must fill the APPLICATION form with utmost care. They should upload all the relevant documents required.
- Admission in LL.B. First Semester will be done on the basis of marks obtained by the Applicant in Graduation.

- Applicants must ensure that the aggregate marks of Graduation (average marks of all the individual years of Graduation) should be filled in the APPICATION Form.
- Only Final year marks of Graduation must not be mentioned in the APPLICATION Form.
- Students are advised to download the Application form and print its hardcopy.
- The Final MERIT LIST will be displayed in the College notice board/College website. Admission/Counselling shall take place in the LAW FACULTY of DAV DEGREE COLLEGE, LUCKNOW. SUCCESSFUL Applicants will be informed vide SMS or EMAIL.
- Before submitting the COLLEGE COURSE FEE, the registration in UNIVERSITY OF LUCKNOW (LERN) is COMPULSORY through LUCKNOW UNIVERSITY WEBSITE.
- The SUCCESSFUL Applicants are requested to report for the Counselling after submitting their COURSE FEE ONLINE vide our website www.davdegreelu.in
- The Registration Fee Shall not be returned under any circumstances. It is used for the welfare of the College and Students.
- Applicants are advised that they should not change their Mobile number and Email id, as further communication shall be done by the College through these addresses only.
- The details of COURSE FEE is available in the College website. Students must carefully pay their Course Fee ONLINE Only vide UPI, NET BANKING, CREDIT CARD, DEBIT CARD etc.

- FEE ONCE PAID SHALL NOT BE RETURNED UNDER ANY CIRCUMSTANCES.
- College strictly follows the reservation in letter and spirit. The reservation policy adopted by BCI and State Government is strictly followed.
- LL.B. is a regular course and thus 75 percent attendance is compulsory.

### NOTE:-

- If the Candidate wants the benefit of Reservation, then the details of the related Certificates during filling of the online application form is necessary. No candidate will get permission for any changes in Reservation/Weightage after the submission of the Admission form.
- The details of the admission procedure shall be displayed on the college website davdegreelu.in Candidates are advised to check for updates regularly on the college website.
- The S.C./S.T./O.B.C. (Non-Creamy Layer) candidates having domicile certificate of Uttar Pradesh shall be given the benefit of Reservation. S.C./S.T./O.B.C. (Non-Creamy Layer) Candidates of Other States shall not be entertained for reservation. Such candidates shall be treated as GENERAL candidates.
- Candidates shall not claim more than one RESERVATION or more than one WEIGHTAGE at a time.
- For Outstanding Players, only State Level or National Level certificates shall be entertained.
- If two or more than two Candidates are having equal marks in GRADUATION examination, then Merit list shall be made on the basis of higher marks in the INTERMEDIATE examination.
- If two or more than two Candidates are having equal marks in GRADUATION, INTERMEDIATE & HIGH SCHOOL examination, then Merit list shall be made on the basis of higher/older age of the candidate.
- EX-SERVICEMAN QUOTA shall be given only to the EX-SERVICEMAN and not their ward.
- CASTE & INCOME CERTIFICATES shall be of within 06 months and shall be verified/verifiable on government website.
- The GIRL CANDIDATES shall be given a WEIGHTAGE of 05 PERCENT on their marks obtained in GRADUATION for LL.B. admission.
- If adequate number of candidates are not found in any RESERVED category, then the vacant seats may be transferred/allotted to the other Reserved category candidates in accordance of the prescribed law.
- The College reserves right to change or amend the admission process without prior notice/notification.
- **FALSE**  If any candidates get admission on the basis of information/IMPROPER of the basis **FAKE** means or on

marksheet/Certificates, his/her admission shall be treated cancelled from the beginning and adequate legal and penal action shall be taken against him/her under IPC.

- Admission in TWO REGULAR courses at a time is NOT ALLOWED.
- If found guilty for MISCONDUCT, the application/admission of any candidates shall be cancelled anytime.
- College reserves the right to cancel any admission at any stage.
- All disputes regarding interpretation of provision of admission rules shall be referred to the Principal/Admission Committee of the College and their decision shall be final.
- All legal matters pertaining to the admission shall be the subject of Lucknow Judicature only.
- Candidates of GENERAL category who wishes to claim the benefit of EWS reservation have to upload the following documents during filling of online application forms:
  - (i) EWS Certificate issued by Competent authority;
  - (ii) Online Income Certificate is compulsory. Manual certificate is not valid. The EWS reservation shall be entertained only after the verification of the Income Certificate online.
  - (iii) The EWS Quota shall be allocated on Over and above seats of the College.
- There shall be a DRESS CODE for the BOYS & GIRLS Student of the College:
  - (i) BOYS/GIRLS: Black Pant; White Shirt; Black Tie; Black Coat& Black Shoe.
